It is a legal requirement in England, Wales, Jersey, Guernsey and the Isle of Man for certain types of new heating and/or electrical work to be notified to the relevant local authority. Installers who are registered with an authorised competent person scheme like OFTEC can self-certify their work as being compliant with building regulations without the need to obtain prior authorisation from your local authority building control.
