Installation of new tea station/snack area within the existing 'Old Vestry'. The installation is to include base units as illustrated, wall units and a worktop and sink. a dishwasher and 5L wall kettle is also to be installed, water supply will be taken from the existing pipes to the north east corner of the room and a new instantaneous water heater will be installed to supply the new sink. The existing floor lino finish it to be replaced with a combination of vinyl and non slip vinyl on a 4mm wbp plywood sheaving over the existing t&g boarded floor. The new sink/dishwasher waste is to be taken through the wall and routed to a new hopper and soil pipe adjacent to that serving the adjacent accessible toilet sink. The existing cleaner's room, which was formerly a wc, is to be reinstated to a wc to provide better facilitites for large services and events.
