Morning Steve

Firstly, apologies for the delayed response.

I can confirm that, following my visit on 24 April, the installation by Piranha AV was complete in the manner discussed at a previous meeting, held on 22 April when the works commenced on site. At the earlier meeting the location and method of fixing of the cameras, microphones and screens was discussed in great detail, along with the cabling routes to be taken to serve the appliances from the router to the north side of the organ on the west gallery. This was also in line with previous discussions we had on site in November 2023.

The final inspection showed the installation to have been completed as discussed on 22 April, with the exception of a slight amendment to one of the cable routes taken, which proved to be an improvement on that envisaged, as it is less visible from the main body of the church.

I would like to commend Piranha AV for the way they have approached this installation. They are clearly experienced in working in this type of environment, open to discussion and suggestions, and respectful of the historic fabric in which they are working. I would be happy to recommend them to any other churches in the Diocese considering undertaking this type of work.
