Repair of the church's Conacher organ. This includes: Removal of all the pipes of the Great and Swell organs and clean down the upper-boards and rack-boards where the pipes stand, to afford attention to each rank and time. Fit new tuning slides throughout the organ, repair all damaged pipes, replace all the smaller treble pipes which are missing, and glue-up the split wooden pipes which at present are untenable. The reed ranks of the Swell (Cornopean and Oboe) to receive careful attention in the workshops of the organ repairer and the tongues and shallots cleaned thoroughly. Details as per organ condition report and quotation from Wood of Huddersfield.
