

**CERTIFICATE OF COMPLETION OF WORKS AUTHORISED BY FACULTY**

**IN THE CONSISTORY COURT OF THE DIOCESE OF TRURO  
TO THE REGISTRAR

CHURCH OF SAINT DOMINICA**

A faculty dated 13 June 2017 authorised the following works:-

**There is an urgent need to replace the floorboards and any other support timbers affected by dry rot in the wooden flooring of the Lady Chapel under the carpet covering and to treat the remaining timbers with appropriate preservatives.**

**In addition, the PCC would like to extend the present flooring to join-up with similar wooden floor boarding at its rear and remove the present Altar Rail, to give a more aesthetic open appearance and a larger seating area for the Lady Chapel itself.**

**As part of the work the PCC would also like permission to remove the existing Victorian flooring tiles, which would be covered by the extended new flooring, on two sides of the present seating area. These tiles would be used and re-laid in the flooring repairs which will take place at the rear of the Nave (and for which a Faculty is already held). The reasons for using these tiles is that:**

- (a) there are many broken tiles at the rear of the Nave needing replacement;**
- (b) finding suitable replacements is proving difficult - only a French source has been located at present. The cost is much higher and the sizes are metric, which will mean that they will need resizing to fit; and**
- (c) the existing tiling in the Lady Chapel would be permanently hidden from view in any case.**

**The whole wooden floor area would be stained to match upon completion, instead of re-laying the carpeting, as recommended by the Surveyor in the QI.**

Subject to the following conditions:-

- The edge of the new floor space is defined by a border to enhance the visual impact; and**
- A dark stain is applied to the new floor so as to match the existing woodwork.**

There are no conditions to be satisfied.
